

## **New Protocol for taking dance classes with Step N Dance "SND"**

All students must read before returning or attending any of Step N Dance (SND) dance class location. Below are the regulations we will be implementing in order to provide the safest possible environment for our students and staff.

- 1) If any of the following applies to you, we respectfully ask you to stay home:
  - i) You have traveled in the last 2 weeks by plane.
  - ii) You have been around anyone experiencing symptoms in the last two weeks.
  - iii) You have experienced any symptoms related to Covid-19 in the last two weeks.
  - iiii) You have a temperature above 100 degrees.
  
- 2) When entering the SND dance class location students must have their temperature taken. If you have a temperature above 100 degrees you will be asked to go home.
  
- 3) All students must sign a liability waiver before entering or attending any SND dance class location for the first time. Please see the waiver below.
  
- 4) All students must use hand sanitizer upon entrance to the SND dance location. We highly encourage you to bring your own hand sanitizer in an effort to help keep the SND supplies fully stocked, and as a measure of safety and comfort in case SND runs out of hand sanitizer.
  
- 5) All students must wear a mask when entering the dance class.
  
- 6) We respectfully ask that you do not bring any belongings into the class. Please keep everything in the trunk of your car. **DO NOT** leave anything in the frontseat or backseat of your car, to avoid any break-ins.
  
- 7) Bathroom use: Students must use hand sanitizer before and after entering and exiting bathrooms. Students must wash their hands after using bathroom/s.

8) The use of cell phones while in dance class is not recommended. We encourage you to wipe down your cell phone before and after leaving dance class. Please keep your phone in your pocket or purse.

We understand that this new protocol is not ideal but we do our best to put your safety and the safety of everyone first and foremost above everything else. As time evolves, we will assess when to resume to normal as we monitor guidelines by the CDC.

We would like to thank our students for their undying loyalty to SND throughout these hard times. Without your support during the quarantine and as we moved on. It would be impossible to continue operation without your continue support.

**Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19**

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

Salsabor Tropical, Inc. D.B.A Step N Dance (SND) has put in place preventative measures to reduce the spread of COVID-19; however, SND cannot guarantee that you will not become infected with COVID-19. Further, attending SND dance classes could increase your risk of contracting COVID-19.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that I may be exposed to or infected by COVID-19 by attending classes at any SND location and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 at any SND class location may result from the actions, omissions, or negligence of myself and others, including, but not limited to, SND employees or class participants.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I may experience or incur in connection with attendance at any SND class location or participation in Club programming (“Claims”). On my behalf, and on behalf of my children, I hereby release, covenant not to sue, discharge, and hold harmless Step N Dance (SND), its employees, agents, third party contractors, third party strategic alliances partners and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of SND, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any SND Latin Dance class.
